



Rescue Tape Application Competition

Terms & Conditions

- The "Rescue Tape Application" Competition will run from 1st September until 16th December 2021.
- Winners must be over 18 years of age and resident in the UK. Employees of Seal It Services Ltd (Bond It) or any of its subsidiary companies, their families, agents or anyone else connected with this promotion, are not eligible to win.

- Mechanics: Buy a roll of Bond It Rescue Tape from a participating retailer. You must retain your proof of purchase. Use the tape to complete your repair and either film it or take a picture of the installation. Send the picture or video to the Bond It Marketing Department via email to marketing@bonditgroup.com with a small write up. Five winners will be selected each month to win £50. The money will be transferred into a designated bank account given by the winners. On the 17th December, the 20 winners photographs will be reviewed by 3 judges and the best application/use will be agreed upon. The overall winner will win £500 which will be transferred to their account on 17th December.
- The Retailer where the winning roll was purchased from will qualify for a £500 credit note that will be issued in January 2022.
- All entries must be made via a registered email address. It's the entrants responsibility to provide the correct information.
- The draws will take place on the 29th of each month, with the final draw being conducted on 17th December 2021. Entries received outside this time period will not be considered.
